Why Carry out Training

Regulation 10, of the Control of Asbestos Regulations 2012 places a mandatory requirement on all asbestos licensed removal contractors to carry out annual asbestos awareness training.

To enable contractors to fully comply the Health and Safety Executive have issued an ACoP L143 'Work with asbestos materials', to assist you in understanding your legal duties.

Chapter 4 of the HSG 247; Asbestos the licensed contractors' guide clearly defines and details the content and asbestos training modules required for each operative, supervisor, managers, directors, supervisory licence holders and licensed scaffolders that are involved in asbestos licensable work.

All training should be provided by someone who is competent to do so, who has had adequate personal practical experience and who has a theoretical knowledge of all relevant aspects of the work being carried out by the employer.
